Are You Disposing of Sharps Safely?



Annually, thousands of people are injured across the country from improperly discarded hypodermic needles, syringes and lancets, often collectively referred to as "sharps." Medical caregivers, solid waste handlers and wastewater operators are at the highest risk of injury, but small children, pets, and other household members can also be injured. The proper storage and disposal of sharps, and all other residential

medical waste, is crucial to help protect your family members and our employees from accidental injury.

Why is the proper disposal of used sharps so important?

Sharps can transmit bloodborne pathogens such as HIV and hepatitis B and C, and should be considered an important public health hazard. Proper disposal helps to guard against the inadvertent sticking of family members, sanitation workers, or the dangerous re-use of the sharps for unintended purposes. Further, what may seem to be a small needle stick will result in costly testing and preventive treatment for the injured person.

We recommend the following steps to safely dispose of your sharps:

 Keep an empty sturdy plastic laundry or fabric softener jug handy in which to collect your sharps. Select jugs that have small-mouth openings and heavy-duty

Did You Know?

In November 2016, the Santa Rosa Board of County Commissioners voted to raise the tipping fee rate at its Santa Rosa Central Landfill by \$1 per ton, per year, effective January 1, 2017 through 2020.

A small increase to accomodate the rise in the Consumer Price Index (CPI) that is provided for in the ECUA's contract with the Santa Rosa Board of County Commissioners will also be included in the new rate.

As such, an increase of \$1.52 per quarter (for 95-gallon can service) is accordingly reflected on the ECUA rate for your sanitation service, effective January 1, 2018.

plastic caps that screw on tightly.

- Keep this container in a safe place, out of reach of children and pets.
- Once the container is full, please dispose of it in your household garbage can, NOT in the recycling can. These sharps are NOT recyclable.
- Never flush sharps down the toilet.
- Never put a used sharp in a container that isn't sturdy enough for sharps such as plastic coffee cans (they have a wide opening and a flimsy plastic lid), drink cans, bottles or plastic food boxes. All these containers will likely break open during the compaction process on the sanitation truck, spilling the sharps throughout the truck's contents.
- Once you've put a used needle into your sharps' container, don't try to remove it.
