



ECUA GENERAL RESOLUTION NO. GR21-46

A GENERAL RESOLUTION AUTHORIZING THE ACCEPTANCE OF BID AND AWARD OF CONTRACT TO ALLIED UNIVERSAL CORPORATION OF MIAMI, FLORIDA, FOR SODIUM HYPOCHLORITE AND PROVIDING AN EFFECTIVE DATE.

BE IT RESOLVED BY THE EMERALD COAST UTILITIES AUTHORITY:

WHEREAS, sodium hypochlorite is used at the Central Water Reclamation Facility (WRF) and Pensacola Beach WRF for wastewater disinfection. The facilities use approximately 450,000 gallons per fiscal year; and

WHEREAS, the current supplier contract expires on July 31, 2021; and

WHEREAS, on May 6, 2021, the Emerald Coast Utilities Authority (hereinafter "ECUA") publically bid the purchase of sodium hypochlorite in accordance with ECUA Code; and the price of \$0.833 per gallon was the low bid when bids were received on June 15, 2021; and

WHEREAS, funds are currently budgeted and available in the FY 2021 operating budget in the amount of approximately \$117,000, which reflects the purchase of up to 140,500 gallons through September 30, 2021 and were budgeted in FY 2022 in the amount of \$312,000, which reflects the purchase of up to 374,500 gallons through July 31, 2022; and

NOW THEREFORE, be it resolved by the Emerald Coast Utilities Authority:

SECTION 1. ECUA hereby authorizes the acceptance of the bid from Allied Universal Corporation; and

SECTION 2. ECUA hereby directs and authorizes the Executive Director to execute a Contract with Allied Universal Corporation at \$0.833 per gallon, with funding from the appropriate budget line item.; and

SECTION 3. This resolution shall take effect upon adoption.


