Bids submitted on behalf of an entity that did not complete a site visit form will not be considered.

The principal features of the work to be known as: CWRF-Filter & Chlorine Contact Chamber Flow Diversion ECUA Project Number CS529 Bid Number CC2020-06 FEMA Project Number HMGP DR-4177-027-R (State ID #26) will consist of the construction of flow diversion piping including, but is not limited to, installation of approximately 850 lf of 48-inch ductile iron pipe (with PVC alternate bid item), slide gate, pinch valve, fittings, manhole modifications, and valve actuators. Project will also include the installation of a degassing assembly on a 42-inch pipe.
