

ECUA GENERAL RESOLUTION NO. GR21-10

A GENERAL RESOLUTION AUTHORIZING THE ACCEPTANCE OF BID AND AWARDING CONTRACT; AUTHORIZING THE EXECUTIVE DIRECTOR TO EXECUTE A CONTRACT WITH B & W UTILITIES, INC., IN THE AMOUNT OF \$185,570.94 FOR THE GREENBRIER BOULEVARD WATER MAIN REPLACEMENT PROJECT AND AUTHORIZING THE TRANSFER OF PROJECT FUNDS.

BE IT RESOLVED BY THE EMERALD COAST UTILITIES AUTHORITY:

WHEREAS, on December 17, 2020, the Emerald Coast Utilities Authority (hereinafter "ECUA") solicited competitive bids for Greenbrier Boulevard Water Main Replacement; and

WHEREAS, the project will consist of the installation of approximately 1,860-feet of 6-inch diameter water main and 450-feet of 4-inch diameter water main, along the north side of Greenbrier Boulevard, to include the abandonment/grout filling of the existing 4-inch diameter transite water main; as well as three open-cut asphalt roadway crossings.; and

WHEREAS, the existing transite 4-inch diameter antiquated water main has experienced multiple recent breaks resulting in customer interruptions so the project needs to be expedited and separated from the Scenic Hills project; and

WHEREAS, the existing water main along Greenbrier Boulevard is a vital water main serving the residences along Greenbrier Boulevard, Rawlings Drive and interconnected to the Scenic Hills North Subdivision; and

WHEREAS, the reduced 21-day required bid advertisement period was met as required by Section 13-2(a)(1) of the ECUA Code; and

WHEREAS, the bids were received from the contractors on January 7, 2021 and are shown in the table below.
